5 months, 26 days. That's how long it took 23-year-old Casie Frederick, graduate of Hermon High School, to walk on foot from Georgia to Maine. She completed a northbound thru-hike of the 2,189 mile long Appalachian Trail just a few weeks ago; her journey traversed 14 states, required 5 pairs of shoes, and took her through notable terrain such as the Great Smoky Mountains, Shenandoah National Park, and the White Mountains.

The hiker came across 7 black bears, multiple species of snakes, a handful of mice in shelters, but more often than not, overly generous and helpful hikers and 'trail angels.'

Her inspiration derived from a backpacking trip 6 years ago in the '100 mile wilderness' with her best friend, Nicole

Turmel, and their two older brothers. Nicole

also set off on the difficult journey of the thru-hike, and accomplished 600 miles before unfortunately sustaining a foot injury.

Time to Prepare For Winter Weather

Autumn leaves are falling everywhere. When you put away the rake, be sure to start thinking about prepping your vehicle for winter driving before the weather hits us. The following are some steps people can take to prepare themselves for the upcoming winter season:

- 1. Check or change your vehicle's tires. Check your tire pressure. Make sure your vehicle is not equipped with summer tires or tires that are low in tread. If you are driving on freezing roads, ice or snow covered roadways you will not be able to maneuver your vehicle safely for the road conditions.
- 2. Check your vehicle's antifreeze. May sure the level is appropriate and it is conducive to sub-zero freezing temperatures.
- 3. Check your vehicle's windshield wipers and washer fluid. Make sure you have adequate winter wiper blades and suggested de-Icer washer fluid to prevent ice from freezing on your windshield. Make sure your windows and windshield are always clear of ice and snow.
- 4. Check your vehicle's battery to make sure it is fully charged and able to start in sub-zero temperatures. Your vehicle will not run without an adequate battery and being stranded in freezing temperatures is not fun.
- 5. Watch for animals while driving (especially at night). Deer and Moose are mostly nocturnal animals this time of year and are often visible during the evening and night time hours while they search for food. Make sure both of your headlights are working correctly. It is not uncommon for headlamps to "burn-out" when the temperatures start to drop below normal.
- 6. Think ahead and pack some items to keep in your vehicle that you may be able to use during an emergency situation. Items such as a cell phone, water, food or snacks, bag of salt or sand, shovel, reflective clothing, blankets, jumper cables, tow strap, first-aid kit, flashlight with extra batteries, extra coat, gloves or winter hat.
- 7. Most of all, SLOW DOWN. Make sure you drive using a "safe speed" conducive to the weather conditions. If the weather conditions mean you have to drive slower than the posted speed limit, then so be it! Plan ahead and give yourself time to travel safely. Your life and the life of your passengers are the most important factor of all!

Thank you to all who attended the Fire prevention Week Open House held at the Hermon Fire Station on October 14th! We had a great response from the community! We are including a few pictures from the event and look forward to an even bigger and better event next year!

As we move into the fall and winter months, now is the time to make sure you are ready to be fire safe and aware of the additional risks that come with the increased use of heating equipment.

- Heating equipment is involved in one of every six reported fires and one in every five home fire deaths. Have your heater, fireplace, flue and chimney checked now by a reputable heating company service technician.
- Keep anything that can burn at least three feet from any heating source like fireplaces, wood stoves, radiators or space heaters.
- Test any smoke alarms that are in your home for proper operation. You should have at least one on
 every level of your home and in each sleeping area. If you need smoke alarms or assistance in testing
 them, please do not hesitate to contact us here at the fire department and we will be happy to assist
 you.
- Sleep with your door closed! A closed door can make the difference between being able to survive and escape a home fire, or not.
- A disabled smoke alarm cannot save your life. Smoke alarms should be replaced every ten years, or according to the manufactures specifications.
- Develop an escape plan with at least two ways out of every room!

 Practice your plan with your family to ensure that everyone knows what to do if there is a fire! Need help developing a plan? Give us a call! We will be happy to assist you in developing a plan for your home.
- NEVER empty fireplace or wood stove ashes into anything other than a metal container and NEVER keep that container in your home or garage!! Keep ashes covered and stored OUTSIDE a safe distance from any building or structure.
- If a fire occurs in your home, GET OUT, STAY OUT and CALL 911!!

The Senator's Corner



The issues that come before the **Joint Government Oversight Committee** both alarm and reassure me. The very existence of the committee reassures me. We conduct independent, objective reviews of State agencies and programs. Our mission is to ensure that public funds are effectively, efficiently and economically managed, and that they are spent for the intended purposes. The staff is excellent, professional, and vigilant.

What we uncover, however, can be alarming. Here are three programs we are currently investigating:

- 1.) Pine Tree Development Zones: These were established in 2003 and provide tax credits for companies that provide new jobs in economically depressed areas of Maine. Twelve business leaders testified before the Committee in strong support. The problem: the rules for getting these credits have loosened over time and the data on new job creation in rural areas is meager at best. We need to think carefully about whether we are spending our tax dollars wisely.
- 2.) Referenda: A careful reading of Question #1 on November's ballot calls attention yet again to the problem of ballot referenda financed by opaque and mysterious out-of-state entities. The source of the money behind Question #1 on November's ballot is almost as obscure as its message. The massive advertising campaign fails to even hint to the voter that the Title of Question 1 is *An Act To Allow Slot Machines or a Casino in York County.* The 5st Amendment protects the right to spend money on political causes but we need greater transparency.
- 3.) Temporary Aid for Needy Families (TANF): Is the Department of Health and Human Services providing adequate support for families, kids, the elderly, and others in Maine who are needy, hungry, and meet other TANF requirements? The total number of people served by TANF has decreased from 38,000 to 11,000 between 2010 and 2016 while the number of hungry Mainers has increased. Why? I brought this issue to the Committee because it is one of particular concern to me.

<u>State of Maine - Referendum Election, November 7, 2017 - Listing of Referendum Questions</u>

Question 1: Citizen's Initiative

Do you want to allow a certain company to operate table games and/or slot machines in York County, subject to state and local approval, with part of the profits going to the specific programs described in the initiative?

Question 2: Citizen's Initiative

Do you want Maine to expand Medicaid to provide healthcare coverage for qualified adults under age 65 with incomes at or below 138% of the federal poverty level, which in 2017 means \$16,643 for a single person and \$22,412 for a family of two?

Question 3: Bond Issue

Do you favor a \$105,000,000 bond issue for construction, reconstruction and rehabilitation of highways and bridges and for facilities or equipment related to ports, harbors, marine transportation, freight and passenger railroads, aviation, transit and bicycle and pedestrian trails, to be used to match an estimated \$137,000,000 in federal and other funds, and for the upgrade of municipal culverts at stream crossings?

Question 4: Constitutional Amendment

Do you favor amending the Constitution of Maine to reduce volatility in state pension funding requirements caused by the financial markets by increasing the length of time over which experience losses are amortized from 10 years to 20 years, in line with pension industry standards?
