  - -In response to Mr. Carr, Mrs. Biberstein replied that spring athletes should be out on fields within the next ten days, and pending budget approval, plans are to resurface the tennis courts this summer.
  - -In response to Mrs. Farnham, Mr. Snyer replied that a meeting with the architect re a HES construction project is scheduled for Thursday this week.
  - -Mr. Reynolds suggested the townwide distribution of information about the football program and then offering residents the opportunity to vote in November as to whether they support funding the program in the school budget.

## Item IX: 2017-2017 Budget

Mrs. Duran stated that there is currently a \$37,000 deficit and recommended that the School Committee approve the expenditure budget of \$12,853,549, allowing Mrs. Byers time to continue working on the revenue balance. Discussion ensued re the unassigned fund balance, capital improvements, reserve accounts, athletics, etc.

Mrs. Farnham motioned, seconded by Mr. Harris, to support funding the football and freshmen basketball programs.

Mrs. Duran provided 2015-2016 football costs totaling \$19,573. Mr. Carr stated that he could not support funding totaling \$26,573.

Mrs. Farnham amended her motion, seconded by Mr. Harris, to include \$22,000.

Voting for: Carr, Farnham, Harris

Voting against: Snyer, Reynolds

Mrs. Farnham motioned, seconded by Mr. Harris, to add an additional \$22,000 to the 2016-2017 budget.

Unanimous vote (5)

This amount translates to asking the town to raise an additional \$281,328.

Mr. Carr motioned, seconded by Mr. Harris, to approve a 2016-2017 expenditure budget of \$12,875,549.

Mrs. Duran asked for the School Committee' support at the May 5 Town Council meeting.
