NOTE: A permit must be obtained from the Town Office before any new culverts are installed.

If culvert installation is done prior to obtaining a permit then an "after the fact" permit must be applied for. The cost of an "after the fact" permit shall be \$20.00. Once the Public Works Director has given notice that an "after the fact" permit is needed and is not applied for within 24 hours the cost of the permit shall double.

Anyone violating this policy shall be subject to a penalty of \$100.00 per day. Each day that the violation continues shall constitute a separate offense. If legal action is required, the offender shall be liable for reasonable attorney fees and costs authorized under 30A, MRSA ss 4452

NOTE: Approval for a driveway entrance does not guarantee the parcel to be a buildable lot.
