- **ARTICLE 4:** To see what sum the Hermon School Department will be authorized to expend for Special Education.

School Committee & Town Council Recommends \$2,233,246.

ARTICLE 5: To see what sum the Hermon School Department will be authorized to expend for Career and Technical Education.

School Committee & Town Council Recommends \$0.

ARTICLE 6: To see what sum the Hermon School Department will be authorized to expend for Other Instruction: Summer School, Extra and Co-curricular Activities.

School Committee & Town Council Recommends \$447,062.

School Committee & Town Council Recommends \$35,000.

ARTICLE 14: To see what sum the Town of Hermon will appropriate for the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act.

Recommends \$10,090,814 and to see what sum the Town will raise as the Town's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688.

School Committee & Town Council Recommends \$4,104,799.

The school administrative unit's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality <u>must</u> raise to receive the full amount of state dollars.

ARTICLE 15: To see what sum the Town of Hermon will raise and appropriate for the annual payments on debt service previously approved by the town voters for non-state funded school construction projects, or non-state funded portions of school construction projects in addition to funds appropriated as local share of the Town's contribution to the total cost of funding public education from pre-kindergarten to grade 12.

School Committee & Town Council Recommends \$470,810.

Non-state funded debt service is the amount of money needed for annual payments on Hermon's long-term debt service for major capital school construction projects that are not approved for state subsidy. The bonding of this long-term debt was previously approved by the voters.

ARTICLE 16: Shall the Town of Hermon raise and appropriate \$374,291 in additional local funds, which exceeds the State's Essential Programs and Services allocation model by \$374,291 as required to fund the budget recommended by the School Committee?

The School Committee recommends \$374,291 for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services funding model. Additional funds needed for increases in salaries and benefits, loss of part of State subsidy for System Administration costs, and coverage of co-curricular and athletic programs not fully funded by the State EPS formula.

School Committee & Town Council Recommends \$374,291.

The additional local funds are those locally raised funds over and above the Town of Hermon's local contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help the Town of Hermon budget for educational programs.

ARTICLE 17: To see what sum the Town will authorize the School Committee to expend for the fiscal year beginning July 1, 2018 and ending June 30, 2019 from the Town's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Act, non-state funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for support of schools.

School Committee & Town Council Recommends \$13,906,314.

ARTICLE 18: To see if the Town will authorize the school committee to expend in addition to Article 17, any sums as may be received from state and federal grants, aid, and receipts during the fiscal year beginning July 1, 2018 and ending June 30, 2019 for school purposes provided that such grants, aid and receipts do not require expenditure of local funds not previously appropriated?

School Committee & Town Council Recommends YES

ARTICLE 19: Shall the Region Four Vocational Budget as approved by the Cooperative Board for the year July 1, 2018 – June 30, 2019 be approved in the amount of \$2,651,077?

Cooperative Board for Regional Vocational Budget is not subject to amendment from the floor. It may be accepted or rejected by the voters. Hermon's share of the Region Four budget is \$0.

News from the Penobscot County Sheriff's Office

As spring and summer approaches the weather will become warmer. People will be out and about more often, especially during the night time hours.

Over the past couple of weeks some surrounding towns have been hit with several residential and motor vehicle burglaries. Some of these burglaries have occurred during the night time hours. It should be known that burglars are not always from the same town or from the areas where the burglaries occur. We have seen in the past where some

burglars drive to areas in surrounding towns and get out and walk on foot during the night time hours. Town residents may live in a nice quiet neighborhood, but sometimes these are the areas which burglars target as they know they are quiet and often property is unsecured.

Here are a few safety tips to help prevent crime in your area:

- 1. If you leave home lock all your doors and windows. Even if it is for a short time. Daytime burglaries are more frequent as burglars know that residents are usually at work during the day time hours.
- 2. During the night time hours lock your doors and all single level windows to your residence. Also lock the doors to your vehicles and never leave the keys in the ignition. People are out and about at night as the nights are warmer. Motor vehicle burglars typically do not target locked vehicles and they move on.
- 3. If you keep valuables in your vehicle, store them out of plain sight.
- 4. Leave outside lights on at night or install motion detection lights. Burglars do not like to be visible at night and often this can create a deterrence.
- 5. If you go away to camp, go on vacation or leave for the weekend tell a neighbor. This is a good way to meet your neighbors and maybe you can return the favor for them if they go away.
- 6. If you go away make your home look occupied. Connect interior lamps to automatic timers.
- 7. Don't let daily deliveries of mail or newspapers build up. Contact the post office or have a trusting neighbor or friend pick them up for you.
- 8. Arrange your lawn to be mowed if you are going away for an extended period of time.
- 9. Always lock your garages, shed and basement windows.
- 10. Never leave notes on your door such as "gone shopping", "gone for the weekend", "be back soon", etc.
- 11. If you observe suspicious people, vehicles or activity, **report it to the police** *immediately*. Write down license plate numbers and descriptions. Do not wait! You have to be the eyes in your neighborhood.
- 12. If you notice a burglary report it *immediately*. Do not enter your home or vehicle. Do not touch or clean up anything. Call from a cell phone or a neighbor's residence. Wait for the police to arrive.

If you follow some of these tips you are less likely to become a victim. DON'T BE A VICTIM!

The Senator's Corner

Ranked Choice Voting



Maine voters approved Ranked Choice Voting in November 2016 and the Maine Supreme Judicial Court recently ruled that it is constitutional. **All** candidates in the June 12, 2018 **primary** will be elected by Ranked Choice.

How does Ranked Choice Voting work?

"Votes are counted in rounds. In the first round, if a candidate receives more than 50% of the first choice votes, that candidate is declared the winner and the election is over. If no

candidate receives a majority of first-choice votes, the election continues to another round, and the candidate with the lowest number of votes is eliminated from the race. Next, the ballots of the voters who selected the eliminated candidate as their first choice are re-assigned to their second-choice candidate. If any candidate achieves a majority in the second round, that candidate is declared winner and the election is over. If there is still no majority winner, the tabulation process continues, round by round, until one candidate reaches a 50% plus one majority." (from the League of Women Voters website, ranked choice vote).

You can see a facsimile of the new ballot on the League of Women Voters web site.

There are a number of details to be worked out by the November election. I will post further details before then. The June election is all set to go forward. This new method allows you to weigh in more fully with your preferences regarding all the candidates and assures that no votes will be wasted. Department of Economic & Community Development

Report 2017-2018

It is important to measure progress concerning Hermon's growth so we can be sure to invest our resources appropriately when considering economic and community development. Looking back over the last year we grew our business list substantially by adding new companies with wide and varied interests while others expanded in place adding additional jobs.

Landscape Supply, Fine Line Striping, Queen City Paving, The Shop, Doug Guerrette's State Farm, First Choice Realty, Ted McLeod Water Wells, Marsh Property Realty, Wicklow Home Builders, Maine Salt Company and the Early Learning Center invested over 2.5 million dollars in Hermon adding 60 new jobs. For each direct job created it is estimated that two other employment opportunities are realized regionally.

Real estate improvements are not the only way to measure gains when looking at levels of progress. The BETE program currently generates over \$260,000 dollars worth of revenue for the Town by protecting 100 businesses from having to pay taxes on \$42,930,200 worth of personal property items used for commercial purposes. When combined with the Tax Increment Finance program which shelters \$34,165,400 from being used as part of our total valuation for State assessment, Hermon benefits by receiving healthy school funding and a lower county tax while contributing dollars to a sinking investment fund used to incentivize business.

As we think about Hermon's low taxes and add strong municipal service, quality education and our premiere location, Hermon is leading regionally as a top growth location in central and eastern Maine residentially and commercially.






Industrial and Commercial

When Hermon considers its industrial inventory, the four leading communities in our area are Bangor (4,189,721 sf), Hermon (1,318,629 sf), Brewer (1,058,195 sf) and Hampden (833,233 sf). Over the last four years our continued growth in industrial square footage creation outpaced all communities shown in the graph below with Hermon adding double the amount of square footage as our closest competitor.

Another leading indicator of healthy business activity is the vacancy rate. Available industrial and commercial spaces shows Hermon at less then 1% currently. With businesses purchasing lots adjacent to their existing properties and inquiries increasing, the DECD office expects the trends of low vacancy rates **and** positive growth to continue.

BURN PERMITS



With the arrival of spring, it is time to clean up from whatever winter may have left behind on your property in terms of branches, brush and other material that may be disposed of by controlled burning.


A burn permit IS REQUIRED for any burning of materials beyond what might be best described as a small recreational campfire. You will need to assure that sufficient adult supervision of the burn is in place and proper tools and equipment are present to control the burn as well.

In all cases, these materials are prohibited to burn; plastic, rubber, Styrofoam, metals, food wastes, chemicals, treated wood or other solid wastes, except for wood wastes.

Burning is allowed only if winds are not expected to be greater than 10 mile per hour and the State Forest Division has classified the fire danger at a Class One or Class two rating for that day. Permits are only valid for the day of issue.

You may receive a free burn permit by stopping by the Hermon Fire Department located at 327 Billings Road (staff is on duty at this location Monday through Friday from 7:00am through 3:00pm) or by going online to the Maine Forest Service website and purchasing a permit for \$7.00 at www1.Maine.gov. You may also ascertain the fire danger rating for the particular day you want to burn at this site.

Please do not hesitate to contact the Hermon Fire Department if you have any questions about open burning. We would be happy to inspect your potential burn pile and location in advance of your burn as well. Be aware, that persons burning without a permit or in violation of the conditions of an issued permit may be subject to costs associated in the extinguishment of such a fire, and may be found to have committed a Class E crime.





From the Desk of State Representative Roger Reed



Due to the passage of a citizen's referendum, Maine citizens will now be required to use a brand new system of voting. It is called Rank Choice Voting (RCV). On June 12, 2018, this method of voting (RCV) will be used for the first time ever in a statewide election as voters cast their ballots in the Primary Election. *Secretary of State has unveiled a new section of the department website* offering several informational resources for voters who are seeking to educate themselves about ranked-choice voting. I kindly ask you to familiarize yourself with this new form of voting. I also strongly recommend if you have elderly family or friends to also help to prepare them for the introduction of RCV. Sample ballots

for all ranked-choice voting races (Only races with three or more candidates will employ the ranked-choice voting process, which requires that one candidate receive a majority of the vote) are available.

- · Frequently Asked Questions
- · A printable PDF "RCV Fact Sheet" for voters to review and share with others in preparation for marking their ballot
- · An implementation plan showing the department's progress and preparation for ranked-choice voting
- · A timeline showing how the State of Maine came to use this voting method in the June 12, 2018 Primary Election
- The draft rules that will govern the process of administering ranked-choice voting, along with the public comments on those rules

Additional resources will soon be added to the RCV Resources page, including:

- The final version of the rules, as they have not been completed yet.
- · An easy-to-understand animation explaining how to mark the ranked-choice ballot and how votes will be tabulated.
