#### HERMON HIGH SCHOOL WINDOW PROJECT

Prior to his retirement, former School
Department Superintendent Gary Gonyar
moved forward on replacing all the windows
at Hermon High School while the school was
vacant. The project was conducted during
the spring by D.P. Porter of Hermon and will
prove to be a welcome addition to our
facilities upkeep.



#### PATRICIA A. DURAN ELEMENTARY SCHOOL SPRINKLER PROJECT

Another vital repair to our schools also took place this past spring. The installation of sprinkler system was conducted and will provide safety measures not previously in place. This project was under the direction of the State of Maine Fire Marshall's office as part of the expansion project.

#### **ROUTE 2/MILLER HILL/ANNIS ROAD INTERSECTION PROJECT**

Maine Department of Transportation is tentatively scheduled to start a safety project at the intersection of Route 2 and Annis Road. This project includes the removal of the Ecotat home and a committed right hand turn lane onto Annis Road. Hopefully there is no delay in this project due to state budget shortfalls- it is long overdue and should help improve traffic safety for all who travel along that corridor.

#### **BILLINGS ROAD PHASE I PROJECT**

Maine Department of Transportation is also scheduled to begin the repair of the Billings Road from the intersection of Fuller Road to Union Street (state route 222) in late summer/early fall 2020. Gardner Construction of Hermon is the contractor and I have full faith they will do a superior job on this project. Phase II is scheduled to be put out to bid this fall for construction in summer of 2021. This phase will include paving Billings Road from Fuller Road to Route 2. Once we obtain more accurate information we will let you know.



#### PELLETIER BROTHERS MOVING TO HERMON!

Across from the Hermon EZ Mart on Route 2 is a recently purchased parcel by Pelletier Brothers of Millinocket. They are expanding their business to Hermon and will provide additional manufacturing jobs in the near future! Congratulations to their business!

#### HERMON SCHOOL REOPENING

Residents were recently informed of the Hermon School Department's plan to reopen schools this fall. While the plan is being implemented I strongly encourage each of you to reach out to the Superintendent of Schools, Jim Chasse, on any questions you might have regarding this very important endeavor. Mr. Chasse, school committee members, and staff have worked hard on this plan- the safety of our children, family and staff is very important to us all.



#### **Back To School - Driving Safety Tips**



As summer draws to an end, back to school season is in full effect. School days bring congestion on the roadways particularly in the morning hours when commuter traffic is the heaviest. Yellow school buses will be busy picking up children. Kids will be walking and riding their bicycles to school. Parents will be in a hurry to drop their kids off at school to make it to work on time. All in all, the number one safety concern is the safety of our children. Here are a few tips to exercise to make sure everyone is safe:

- 1. Please exercise caution and patience while the buses are stopped picking up or dropping off children on the roads or in school parking lots. More children are hit by vehicles near schools than any other location. Remember that it is illegal to pass school buses when the flashing red lights are activated. This is the law on the public way and in school parking lots when they are unloading and loading children. Please do not try to beat the red lights while the yellow lights are flashing. Instead be prepared to stop. Adjust your morning schedules and leave for work earlier if you find that school buses are hindering the amount of time you have to travel to work in the mornings.
- 2. Share the roadway with young pedestrians walking on foot or riding on bicycles. Watch for children walking along the roadways and on sidewalks. Watch for children crossing the roads and crossing in crosswalks. Please take extra care to look out for children in school zones and in residential areas.
- 3. Obey the rules of the roadway. Stay off the phones and no texting while driving. Whether children walk, ride their bicycles or take the bus to school, it is extremely important that they and the motorists around them take the proper safety precautions.

**NOTICE:** MDOT road construction is scheduled to start this fall with the four-way intersection of Route 2, Klatte Rd and Annis Rd. Morning commuter traffic on Route 2 is very heavy in the mornings and early evenings. Please be patient with traffic issues as the construction, heavy commuter traffic and school traffic will be busy during these times. Please keep in mind that traffic may be delayed (especially in the mornings) and you may have to adjust your schedule to arrive at your destination in a timely manner.

PLEASE BE PATIENT.

On behalf of the Town of Hermon and the Penobscot County Sheriff's Office, please make this a safe school year for everyone!

#### **Community Projects & Infrastructure Update- Hermon DECD**

Hermon's Department of Economic & Community Development coordinates infrastructure improvements, upgrades to utilities for business growth and safety related projects for the community. The entire staff, manager and Town Council at the Town of Hermon contributes to this effort adding value at different intervals during the process. Our collective efforts maintain a strong competitive advantage regionally for new residential and business growth using cost effective and efficient best practices for project completion. The list below describes some of the current projects underway. For more information on any item, please call the Hermon DECD office at 848-1010 or email SPerkins@Hermon.net.

#### Annis Road and Route 2 Traffic Safety Project

Hermon was awarded a safety grant by MDOT and Federal Highway Authority for traffic safety improvements to the Route 2 and Annis road intersection near ECOTAT Gardens. This project will be awarded this fall to the successful bid award winner after contract documents are finalized. The project will remove the house on ECOTAT property and create a dedicated, full width right hand turning lane onto Annis Road and install islands for traffic queuing that will improve sight distance. The project also features a flashing two-way beacon across the intersection to warn approaching motorists to exercise caution.

#### **Cianbro Solar Project-Hammond Street**

Cianbro will partner with the Sport's Arena to install a 4.9 megawatt solar array behind the existing business located at 1640 Hammond Street. DEP permitting and the Hermon Planning board reviews have been completed for a fall 2020 project start. A similar project has been accepted by power grid operators who determine capacity at another location in Hermon. Look for more on these future projects soon!

#### Natural Gas Extension—Coldbrook Business Park

The Hermon DECD office facilitated and Bangor Natural Gas installed a main natural gas line from Coldbrook-Emerson Mill road intersection near Dysart's to Logistics Lane at no cost to the tax payer. Next steps include a business survey, design and installation into Coldbrook Park by coordinating with CP Rail, Bangor Natural Gas and Hermon businesses interested in accessing natural gas in FY 2021.

#### **Billings Road MPI 2020 (Fuller Road Intersection - Union Street)**

The Town of Hermon has entered into a municipal partnership initiative to share the cost of a pavement rehabilitation at Billings road for fall 2020 construction. The project will include tree removal and drainage improvements, right of way clearing for sight distance and cross culvert replacement before a shim and overlay for this section of roadway. Hermon DECD has been awarded a grant for the remaining section of Billings road to be accepted by vote during the 2021 budget process if the community approves. The cost share is a 50%-50% match with MDOT for a 10 year useful life project certified by design engineers.

#### BACTS Signal Upgrade-Coldbrook/Odlin/Emerson Mill Road

A Bangor Area Comprehensive Transportation System grant was awarded to Hermon after DECD application for a signal upgrade at the "Dysart's" intersection at Coldbrook-Emerson Mill-Odlin Road. New signals will

#### **HERMON SCHOOL DEPARTMENT**

#### **Special Education Child Find Notice**

The Hermon School Department is in compliance with federal and state regulations regarding the delivery of services to all children with special needs.

Federal statutes (I.D.E.A.) requires that the School Department identifies, locates and evaluates all children with disabilities, ages 3-20, residing within the school district. Residents who believe that their child is in need of special education services, whether attending public or private school, should contact Cindy Badger, Director of Student Services, 31 Billings Road, Hermon, ME 04402, Tel. 848-4000, X 6004.

#### **Annual Notice of Student Education Records and Information Rights**

The Family Educational Rights and Privacy Act ("FERPA") provides certain rights to parents and eligible students (18 years of age or older) with respect to the student's education records. A copy of the Hermon School Department's policy statement and administrative procedure is available in each school.

#### **Inspection of Records**

Parents/ eligible students may inspect and review the student's education records within 45 days of making a request. Such requests must be submitted to the Superintendent or building administrator in writing and must identify the record(s) to be inspected. The superintendent or building administrator will notify the parent/eligible student of the time and place where the record(s) may be inspected. Parents/eligible students may obtain copies of education records at a cost of ten cents (\$0.10) per page copied.

#### **Amendment of Records**

Parents/eligible students may ask the Hermon School Department to amend education records they believe are inaccurate, misleading or in violation of the student's right to privacy. Such requests must be submitted to the Superintendent or building administrator in writing, clearly identify the part of the record they want changed and specify why it is inaccurate or misleading. If the superintendent or building administrator decides not to amend the record as requested, the parent/eligible student will be notified of the decision, their right to request a hearing and information about the hearing procedure.

#### **Disclosure of Records**

The Hermon School Department must obtain a parent/eligible student's written consent prior to disclosure of personally identifiable information in education records except in circumstances permitted by law.

#### **Directory Information**

The Hermon School Department designates the following student information as directory information that may be made public at its discretion: name, participation and grade level of students in officially recognized activities and sports, height and weight of student athletes, dates of attendance in the Hermon School Department, and honors and awards received, and photographs and videos of student participation in school activities open to the public (except photographs and videos on the Internet). Parents/eligible students who do not want the Hermon School Department to disclose directory information must notify the Superintendent in writing by September 15<sup>th</sup> or within thirty (30) days of enrollment, whichever is later.

#### Military Recruiters / Institutions of Higher Learning

Military recruiters and institutions of higher education are entitled to receive the names, addresses and telephone numbers of secondary students, and the Hermon School Department must comply with any such request, provided that parents have been notified of their right to request that this information not be released without prior written consent. Parents/eligible students who do not want the Hermon School Department to disclose this information must notify the Superintendent in writing by September 15<sup>th</sup> or within thirty (30) days of enrollment, whichever is later.

#### **School Officials with Legitimate Educational Interests**

Education records may be disclosed to school officials with a "legitimate educational interest." A school official has a legitimate educational interest if he/she needs to review an education record in order to fulfill his/her professional responsibility. School officials include persons employed by the Hermon School Department as an administrator, supervisor, instructor or support staff member (including health or medical staff and law enforcement unit personnel);

members of the Hermon School Committee; persons or companies with whom the Hermon School Department has contracted to provide specific services (such as attorneys, auditors, medical consultants, evaluators or therapists); and parents, students and volunteers serving on an official committee (such as a disciplinary or grievance committee) or assisting a school official in performing his/her professional responsibilities.

#### **Health or Safety Emergencies**

In accordance with federal regulations, the Hermon School Department may disclose education records without prior written consent in a health and safety emergency to any person whose knowledge or the information is necessary to protect the health or safety of the student or other individuals.

#### **Other School Units**

As required by Maine law, the Hermon School Department sends student education records to a school unit to which a student applies for transfer, including disciplinary records, attendance records, special education records and health records (except for confidential health records for which consent for dissemination has not been obtained).

#### Other Entities / Individuals

Education records may be disclosed to other entities and individuals as specifically permitted by law. Parents/eligible students may obtain information about other exceptions to the written consent requirements by request to the Superintendent or building administrator.

#### Complaints Regarding School Department Compliance with FERPA

Parents/eligible students who believe that the Hermon School Department has not complied with the requirements of FERPA have the right to file a complaint with the U.S. Department of Education. The office that administers FERPA is:


