The Hermon Holl of March, 2021



It started with a picture of the Leathers Corner School donated to the Hermon High School Library Media Center by Dolly Hackett, long term Hermon Resident. Dolly is an Overlock and a Pomeroy; two families that have lived in Hermon since the 1800s. I received framed pictures of children at a schoolhouse dressed in "Little House on the Prairie" or Laura Ingalls Wilder style clothes. Because I did not know where or when the photos were taken, I contacted Dolly Hackett, and my historical journey began.

Dolly and I met and she informed me of the history of her Family, both the Overlocks and the Pomeroy's journey to Hermon. I learned that the Pomeroys of Normandy, France

were connected to William the Conqueror. Ralph de la Pomereau was a knight for William. He was the chief of staff for the Battle of Hastings. The Overlock history was equally fascinating, and she informed that their name was originally Oberlach, when the Overlocks were still in Germany. They were Lutheran and came to America to practice their faith more freely. Dolly is cousin's with Hermon High School's Ricky Overlock. They share great Aunts and Uncles. Jacob Overlock settled in Hermon Maine in 1835. Most of the historical Overlocks can be found at the Snow's Corner Cemetery in Hermon, and at the Hermon Pond Cemetery.

According to the family history books schools started in Hermon just two years after it was incorporated as a town in 1814. Three school houses were built in Hermon in 1816. By 1832 there were 7 schools and 328 students. Hermon High School now boasts over 500 students. The town has grown!

Dolly also included a list of all the families in Hermon who can trace their heritage to the Pomeroy/Overlock family. Dolly believes her family, the Overlocks and the Pomeroys, helped build the town of Hermon that it is today. Many of their descendants are Hermon residents to this day. The Hermon High School Library Media Center plans to upload photos to our website. It is our hope that looking at these historical pictures will inspire the next generation of Hermon to visit the past. The library also has the framed photos of the Leathers Corner School from 1894 when the grandchildren of the first Overlocks and Pomeroys to settle in Hermon were in attendance.

Dolly's mother Helen Snow Hasey, an Overlock and a Pomeroy and Marvin Overlock, her cousin and a teacher at Hermon High school, collected pictures and texts for years. Dolly has saved them and committed the history to memory. Some notable Overlocks and Pomeroys are William Overlock, born 1918 married to Olive Pomeroy (Ricky Overlock's grandparents). William also known as Willie was a decorated World War II Veteran. Jacob Overlock served in the War of 1812 as a private in Thatcher's Third Regiment. One of Jacob's sons, Christopher Overlock, died in the Civil War. And Dolly's mother, Helen Snow Hasey, put all this information together for her children to remember, and now future generations can learn about their history in Hermon thanks to Helen, Marvin, and Dolly.

<u>COVID CLINICS</u> Northern Light Health and the Maine CDC are urging eligible Mainers to fill open appointment slots for the COVID-19 vaccine at the Cross Insurance Center in Bangor. Maine CDC Director Dr. Nirav Shah made the announcement Thursday during a coronavirus briefing. He said that when

Northern Light Health staff reviewed their scheduled appointments, they found many openings. You do not have to be a Northern Light Health patient to get a vaccine at the Cross Insurance Center.

The appointments are only for people eligible under the state's phased approach: currently, that includes Mainers age 60 and older, and those in Phase 1A.

Northern Light said they also have appointments at clinics in Palmyra, Presque Isle, and "a limited number" of appointments in Blue Hill.

CAPITAL IMPROVEMENT PLAN FY2022

Hermon Town Council has approved a Capital Improvement Plan for Annual Town Meeting on Thursday, 10 June 2021. Included in the plan include:

Repairing Billings Road from Fuller Road to Route 2. This is a joint project with MDOT that is sharing the cost equally. The project will be primarily paving with some groundwork.

Repairing a section of Black Stream Road from bridge to Route 2. This section of road needs attention in drainage, ditching, shoulder repair and paving. This is going to be a phased project over a few years due to the road being local and the cost is the responsibility of only the Town. Here are just a few of the projects we plan on for the summer of 2021:

Repave and repair Hermon High School parking lot- School Department will repave and repair the Hermon High School parking lot including the entrance, drainage and resetting the storm water basins.

Purchase an SCBA Decon Washer for the Fire Department - Fire Department is interested in purchasing an SCBA decon washer system for personnel's SCBA equipment. This is a long overdue purchase that will complete the washing and cleaning of SCBA equipment.

Purchase a new Fire Truck to replace engine 401 - This request is for the replacement of Engine 401. 401 is a 1995 Freightliner commercial engine manufactured by Metalfab out of Canada. The unit was purchased used in 1996. Maintenance and operating costs on this unit are climbing and the truck is a major system or frame failure from going out of service. Most recently a major pump overhaul was conducted at a cost of \$23,000.00. Annual maintenance costs are at approximately \$8,000.00 per year.

The HME engine being requested would come with a 36-month general bumper to bumper comprehensive warranty, a 10 year structural warranty and a 20 frame warranty. Maintenance costs on this new engine should be nearly 0 out of pocket for at least three years.

The Town has done a great job saving money toward the replacement purchase over the past decade so that the purchase is going to require no debt. Total cost of the truck if agreed to is \$585,000. Truck will be delivered in summer of 2022.

ROAD POSTINGS

Each town road has been posted for weight limits- we strictly enforce the law on these since the roads are important to our resident's safety and travel. While we understand heavy trucks need to get to various locations passing over Town of Hermon roads above 32 degrees is not allowed. Please obey the law- everyone pays for these roads!

FY2020 AUDIT RESULTS- The Town of Hermon, including the School Department, recently had its financial statements audited by RKO (Runyon, Kersteen and Ouellette, Certified Public Accountants). During the audit RKO reviewed all of our financial transactions and policies and determined the Town is in extremely good financial condition due to excellent procedures and oversight from our Finance Department led by Michael Chammings, Finance Director and Wendy Wiles-Scott, Bookkeeper. I want to personally thank them for their attention to detail and job well done!

BEWARE: IRS Scam!

It is that time of year again when everyone is busy filing their 2020 taxes. With this we begin to see an increase in telephone scams. Last year we received reports of scammers who were impersonating the IRS. They were targeting seniors around the Town of Hermon, along with other neighboring towns. Callers would claim to be from the IRS, telling intended victims they owe taxes and must pay using a pre-paid

debit card or wire transfer. The scammers threaten those who refuse to pay with arrest, loss of a business or loss of a driver's license.

The callers who commit these IRS scam's often:

- · Use common names and fake IRS badge numbers.
- They know the last four digits of the victim's Social Security number.
- They make your caller ID appear as if the IRS is calling.
- They send bogus IRS emails to support their scams.
- They sometimes call a second time claiming to be the police or DMV. They spoof your caller ID with a local LE agency phone number to help support their claim.

The truth is the IRS usually first contacts people by mail about unpaid taxes and **NOT** by phone. The IRS won't ask for payment using a pre-paid debit card or wire transfers. The agency also won't ask for a credit card number over the phone.

If you receive a suspicious call like this and don't feel comfortable, **PLEASE** make contact with the Penobscot County Sheriff's Office (945-4636). We are more than happy to answer any of your questions and we do not want anyone, including our seniors to be defrauded. Please do not become a victim of these scams no matter what they tell you!

History of the Boston Post Cane

On August 2, 1909, Mr. Edwin A. Grozier, Publisher of the Boston Post, a newspaper, forwarded to the Board of Selectmen in 700 towns* (no cities included) in New England a gold-headed ebony cane with the request that it be presented with the compliments of the Boston Post to the oldest male citizen of the town, to be used by him as long as he lives (or moves from the town), and at his death handed down to the next oldest citizen of the town. The cane would belong to the town and not the man who received it.

The canes were all made by J.F. Fradley and Co., a New York manufacturer, from ebony shipped in seven-foot lengths from the Congo in Africa. They were cut to cane lengths, seasoned for six months, turned on lathes to the right thickness, coated and polished. They had a 14-carat gold head two inches long, decorated by hand, and a ferruled tip. The head was engraved with the inscription, — Presented by the Boston Post to the oldest citizen of (name of town) — "To Be Transmitted". The Board of Selectmen were to be the trustees of the cane and keep it always in the hands of the oldest citizen. Apparently no Connecticut or Vermont towns were included (at one point it was thought that two towns in Vermont had canes, but this turned out to be a bit of a myth).

In 1924, Mr. Grozier died, and the Boston Post was taken over by his son, Richard, who failed to continue his father's success and eventually died in a mental hospital. At one time the Boston Post was considered the nation's leading standard-sized newspaper in circulation. Competition from other newspapers, radio and television contributed to the Post's decline and it went out of business in 1957.

The custom of the Boston Post Cane took hold in those towns lucky enough to have canes. As years went by some of the canes were lost, stolen, taken out of town and not returned to the Selectmen or destroyed by accident.

In 1930, after considerable controversy, eligibility for the cane was opened to women as well.

On the evening of December 17, 2020 Ms. Winnotta Reynolds was asked by her family to take a ride and look at the Christmas lights. On the way back home Ms. Reynolds daughter, Sharon, stated the town office needed speak to Ms. Reynolds regarding her taxes. Ms. Reynolds said Sharon could handle this and she would come in if needed. As Ms. Reynolds came into the Council meeting and had a seat with her family, Manager Kroll went on to talk about the Boston Post Cane and the meaning. Manager Kroll stated we have a VIP among us this evening...Ms. Winnotta Reynolds. She was born on May 20, 1924 making her 96.75 years.

It was a pleasure to present Ms. Winnotta Reynolds the Boston Post Cane and a certificate in her honor. Her name will be displayed on the plaque in the Town Office for all residents to view and admire.

Hermon Track Committee Update

Please join us to hear about plans for a new track facility at the special Council workshop meeting at the High School Auditorium March 10th at 7:00 p.m. Attendance will be limited to 50 residents with masks to allow social distancing. Participation will also be available via Google Meets (meet.google.com/hpd-ybkh-emo) and this information will be posted on the Town website and Facebook page.

The Hermon Track Committee is excited to present a plan to build an 8-lane rubber surface track facility and improve the playing conditions of Pottle Field at the high school complex. The track committee, consisting of school committee members, town councilors, residents, and ex-officio members, have invested considerable time and work over the past 18 months measuring community support for the project, evaluating placement options, and working with an engineering firm to cost effectively convert our ideas into building plans designed to meet Hermon's burgeoning athletic program. Committee members will present the background information that led up to our recommendation and answer your questions at the March 10th meeting.

Pottle Field has hosted spectacular clashes in soccer and football and has been a family gathering site for a generation of Hermon athletes. The Track Committee felt it was important to continue this legacy and worked to keep Pottle Field at the heart of this expanded complex. The proposed track complex will be constructed west of Pottle Field behind the tennis courts and designed to host regional and state conference meets. Considerable engineering was required to fit the track within property boundaries and include space for throwing events, spectator viewing, and equipment storage. The design will also provide capacity to expand the Booster Club's concession stand for all student events. Pottle Field will be rebuilt, starting with ledge removal. A new base will be installed and finished with commercial quality sod to provide an exceptional natural playing surface. With voter approval in June, the track complex and Pottle Field will be completed prior to the fall 2022 season.

We look forward to presenting the plan and answering your questions March 10th!
