#### Annual Town Meeting Budget Approval Thursday, June 10, 2021

To: Courtney Brown, a Resident of the Town of Hermon, in the County of Penobscot, State of Maine, GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Hermon in Penobscot County, Maine, qualified by law to vote in town affairs, to meet at the **High School** Auditorium in Hermon on Thursday the 10<sup>th</sup> day of June, 2021, at 7:00 p.m., then and there to act upon Articles 3 through 31 as set out below. Articles 1 and 2 were acted upon at the Election on 6/8/2021.

**ARTICLE 1:** To elect a Moderator by written ballot to preside at said meeting.

**ARTICLE 2:** To elect all municipal officers and school committee members as are required to be elected.

**ARTICLE 3:** Shall the Town vote to appropriate the revenues received for the following accounts to offset the associated expense accounts, for fiscal year 2022 with approval of the Town Council?

**ARTICLE 10:** Shall the Town vote to authorize the transfer of \$100,000 from the undesignated fund balance to the Fire Department Reserve Account (HERM05)? **Recommended by the Town Council** 

**ARTICLE 11:** Shall the Town vote to authorize an expenditure of up to \$68,901 from Town Office Equipment, Technology Reserve (HERM19) to purchase the upgrade of the computer equipment required for the upgrade including new computers and other equipment/services from Penbay Computers. Said Purchases will be made by 30 June 2022 or funds lapse back to the Town Office equipment, Technology Reserve (HERM19)? **Recommended by Town Council** 

**ARTICLE 12**: Shall the Town vote to authorize the transfer of funds from Tax Incremental Financing (TIF) Revenue in the amount of \$614,738, to off-set authorized expenditures for Economic Development general accounts #11-01-01-01 to 11-01-20-06 in the amount of (\$504,738) including the Valley Satellite drainage project awarded to Gardner Construction and Ryder incentive program; account # 19-02-25-03 TIF Credit Enhancement Agreements (\$110,000)? **Recommended by the Town Council** 

**ARTICLE 13:** Shall the Town vote to authorize and transfer to the Hermon School Department the expenditures of up to \$379,000 from the School Repair Reserve Account (HERM07) for the expenditures at Hermon High School repair, correct drainage, curbing and paving the Hermon High School Parking Lot (\$299,000), the repair to make the Hermon High School front entrance ADA compliance (\$40,000) and at the Patricia A. Duran School to repair the roof off of the cafeteria (\$40,000)? **Recommended by the Town Council**

**Recommends** \$10,787,948.26 and to see what sum the Town will raise as the Town's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688. **School Committee & Town Council Recommends** \$4,239,798.33.

The school administrative unit's contribution to the total cost of funding public education from prekindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality <u>must</u> raise to receive the full amount of state dollars. **ARTICLE 24:** To see what sum the Town of Hermon will raise and appropriate for the annual payments on debt service previously approved by the town voters for non-state funded school construction projects, or non-state funded portions of school construction projects in addition to funds appropriated as local share of the Town's contribution to the total cost of funding public education from pre-kindergarten to grade 12. School Committee & Town Council Recommends \$601,060.50

Non-state funded debt service is the amount of money needed for annual payments on Hermon's long-term debt service for major capital school construction projects that are not approved for state subsidy. The bonding of this long-term debt was previously approved by the voters.

**ARTICLE 25** To see what sum the Town will authorize the School Committee to expend for the fiscal year beginning July 1, 2021 and ending June 30, 2022 from the Town's contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Act, non-state funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for support of schools. School Committee & Town Council Recommends \$15,744,085.10

**ARTICLE 26:** To see if the Town will authorize the school committee to expend in addition to Article 23, any sums as may be received from state and federal grants, aid, and receipts during the fiscal year beginning July 1, 2021 and ending June 30, 2022 for school purposes provided that such grants, aid and receipts do not require expenditure of local funds not previously appropriated? School Committee & Town Council Recommends YES

**ARTICLE 27:** Shall the Region Four Vocational Budget as approved by the Cooperative Board for the year July 1, 2021 – June 30, 2022 be approved in the amount of \$3,588,936.95?

Cooperative Board for Regional Vocational Budget is not subject to amendment from the floor. It may be accepted or rejected by the voters. Hermon's share of the Region Four budget is \$0. School Committee & Town Council Recommends YES

**ARTICLE 28:** In the event that the Hermon School Department receives more state education subsidy than the amount included in its budget, shall the School Committee be authorized to use all or part of the additional state subsidy to increase the allocation of finances to reserve funds approved by the School Committee? **School Committee & Town Council Recommends** YES

**ARTICLE 29:** Shall the Town vote to authorize the expenditure of \$30,000 from the School Bus Purchase Reserve (HERM33) to offset a portion of the lease/purchase payment for a school bus in addition to the local appropriation for education? **School Committee & Town Council Recommends** YES

**ARTICLE 30:** Shall the Region Four Vocational Budget as approved by the Cooperative Board for **adult education** for the year July 1, 2021 – June 30, 2022 be approved in the amount of \$315,375.05?

The Region Four Vocational Budget for Adult Education supports adult education classes held at United Technologies Center in Bangor for communities that belong to the Region Four consortium. Hermon's share of the regional adult education budget is \$3,377.00. Town Council Recommends YES

**ARTICLE 31** Shall the Town of Hermon raise and appropriate \$925,296.08 in additional local funds, which exceeds the State's Essential Programs and Services allocation model by \$925,296.08 as required to fund the budget recommended by the School Committee?

The School Committee recommends \$925,296.08 for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services funding model. Additional funds needed for increases in salaries, enrichment programs and field trips, guidance and mental health services, professional development activities and costs of co curricular and athletic programs not fully funded by the State EPS formula. School Committee & Town Council Recommends \$925,296.08.

The additional local funds are those locally raised funds over and above the Town of Hermon's local contribution to the total cost of funding public education from pre-kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and local amounts raised for the annual payment on non-state funded debt service that will help the Town of Hermon budget for educational programs.

#### From the Town Manager



I want to take this opportunity to wish each of you a safe and healthy spring and early summer. The last 14 months have been stressful and chaotic. While I can't predict the future or how soon our everyday life will return to normal I can say things are improving. Enjoy your spring!

<u>ANNUAL TOWN MEETING-</u> Our annual town meeting is scheduled for Thursday, June 10, 2021. Please keep checking our website, http://www.hermon.net for details as they are subject to change. The Annual Town Meeting Warrant will be on the Town's website once it is approved by the Hermon Town Council.

<u>CONGRATS TO OUR GRADUATES</u>- To all the seniors at Hermon High School, I want to congratulate you on your graduation. You are going to move on in life either to continue your education or go into the work force. Either way you will be prepared for that next step. I wish you all the best in your future endeavors!

**<u>BUDGET-</u>** The Town's proposed 2022 budget contains projected road projects such as Billings Road (from Route 2 to Fuller Road intersection), Timberview Drive, Westridge Drive, Beech Ridge, Hillcrest Drive, Bog Road (section near Hampden line) and a few others. As you might not be aware we contract with the Penobscot County Sheriff's Department for our law enforcement services, Gardner Construction for our snow removal, TGP for our street sweeping, LaPlante's Lawn Care, LLC for cemetery and municipal property mowing, Hermon Volunteer Rescue and First Aid Squad for our EMS services and many others to provide services to the public.

**<u>PRIMARY ELECTION</u>**- Unless the State of Maine Secretary of State decides to change the date of the primary election it will be held on Tuesday, June 8, 2021. As of right now we have no guidance on what, if any, requirements will change. Please be patient and contact the Town Office if you have any questions.

**Transfer Station**- The Transfer Station is now open on Saturdays! It is available to Hermon residents only. Please refer to the Town of Hermon website for details on what is allowable to be discarded. Included in the FY22 proposed municipal budget is to open the transfer station on a weekday afternoon. This will help further your recycling needs. I will let you know when that change occurs so the public can get out to and take advantage of the additional hours.



Hermon Elderly Project was established in 1980 as a non-profit corporation with the vision to develop an elderly apartment complex in the Town of Hermon. Interested residents started the process including Kenneth Boulier, Clayton Jewett, Tim Schoppe, Stephen Cole, Theodore Clements, Juanita Littlefield, Marilyn Smith, William Allen, Royce Wheeler and Linwood Littlefield who served as the initial Board of Directors.

Hermon Elderly Project Board of Directors worked with Farmers Home Administration (commonly known as USDA Rural Development today) to secure funding to build the 24 unit complex located on Route 2 known as Boulier Place Apartments. The original loan to build this property was for \$1,093,200 at a 1% interest rate for a 50 year term. The loan was granted in 1982 and with a dedicated group of constructors, Boulier Place Apartments was made ready for tenants by 1983. The property was filled to capacity quickly and continues to maintain a healthy waiting list of people who want to live in this beautiful complex.

Whereas, the mortgage is held by Rural Development (FHA) there are guidelines and restrictions when attempting to rent a unit. A tenant must be 62 years old or older, OR handicapped or disabled. There are also income restrictions. Of the 24 apartments there are only 8 units that have rental assistance. The remaining units are full rent without subsidy.

Hermon Elderly Project is a non-profit. The Corporate membership consists of as many interested persons as possible. Nine of those members are elected as a Board of Directors for three year terms. The Corporate membership meets one time a year to vote in affairs concerning the property and to fill any vacancies on the board. The Board meets after the annual meeting to go over the business of the property and approve the annual budget. They usually meet only once a year unless there is additional business that requires another meeting.

The oversight of Boulier Place Apartments is performed by *Multi Management Group*, owned by Susanne LeVasseur. This management company takes care of all tenant relations and paperwork, government reporting, required subcontracting work and all the financial responsibilities of the property. The management company reports to the Board of Directors regarding essential activities that help maintain a positive experience for all of the residents.

Hermon is fortunate to have a good manager that provides encouragement, fosters a bond with the clients she serves, and in many ways becomes like part of their immediate family. Top professionals like LeVasseur go above and beyond for the seniors in their care. Susanne has "steered the ship" at Boulier Place Apartments for 23 years providing exceptional guidance for all of demands that the facility and residents require.

"The Board and I find it rewarding to offer quality, safe & affordable housing to our seniors and disabled population. We pride ourselves in keeping this 38 year old property in great condition with a modern feel. We are fortunate to have USDA Rural Development's involvement in providing low interest mortgages, rehabilitation loans and grants as well as the rental assistance. I have managed Boulier Place for 23 years through all required renovations and upgrades. When I think of the wonderful tenants I have met over that time, I could not imagine a more fulfilling job", says LeVasseur.

The property at 8 Boulier Place Drive in Hermon (off of Route 2 near Hermon Corner) is 38 years "young" because of LeVasseur's leadership and an active board of interested stakeholders rallying around the project to keep the property healthy and vibrant.

Many updates and renovations have been done over the years. The largest renovation was completed in the spring of 2016 with new roofing, new kitchen cabinets and countertops, bathroom vanities, new electric baseboards, newly paved walkways and ADA accessibility work done in the community room as well as two units completely renovated for ADA.

#### PERSONAL PROPERTY TAX EXEMPTION

#### THE ASSESSING OFFICE HAS MAILED THE ANNUAL BUSINESS PERSONAL PROPERTY DECLARATION FORMS (706-A REQUESTS)

#### Maine Business Equipment Property Tax Relief Programs

The State of Maine has two business equipment property tax relief programs designed to reduce the burden of personal property taxes that businesses pay. The programs vary based on the date the property was placed in service in the state.

#### **Business Equipment Tax Exemption Program (BETE)**

For property placed in service after April 1, 2007, the Business Equipment Property Tax Exemption (BETE) program applies; commonly referred to as the "BETE" program. The exemption applies to most depreciable business equipment, however, certain items are excluded, such, vehicles subject to excise tax, office furniture, lighting, gambling equipment, and property located at a retail sales facility and used primarily in a retail sales activity. Retail equipment will continue to be covered under Maine's Business Equipment Tax Reimbursement program, (BETR) as discussed further below.

A BETE application <u>MUST be filed ANNUALLY</u> with the tax assessor by April 1 of each year, but an extension to May 1 is automatically granted. Further extensions beyond May 1 may be requested in writing to the local assessor. Filing the BETE application on time is critical, as property will be disqualified from the exemption for any year the report is not considered to be timely filed. The exemption application <u>MUST LIST ON THE APPLICATION</u> all eligible exempt property purchased after April 1, 2007 *each year*, not only in the year of purchase. There is no time limit on the number of years the exemption may be claimed, but the business or business owner must apply annually with a completed application and itemized list of personal property requesting exemption on.

The big day is here! The conceptual drawings are complete. The construction schedule is in place. The budget is finalized. We now need your vote to make the plan a reality!


The Hermon Track Committee presented the track complex plan to the School Committee and Town Council where it received unanimous approval. There is also strong support from the business community. The **\$2.4 million** project consists of the following:

- 1. Phase I upgrades to Pottle Field excavate ledge, install proper drainage and soil base, lay high quality sod to insure an excellent natural playing surface. Phase II to be completed at a later date will include the addition of artificial turf matched to the base installed during Phase I.
- 2. Renovate Booster Club concession booth with a central and expanded kitchen and food prep area, storage facilities, and access windows.
- 3. Build an 8-lane rubber surface sanctioned track west of the tennis courts at the High School designed to host local, regional, and state track and field competitive meets. A bonus multi-sport practice field will be available inside the new track.

If approved, the complex upgrades will be completed before the fall 2022 athletic season.

We ask for your vote to support these athletic field improvements June 8<sup>th</sup>.

#### **Reminder: Hermon Consumer Fireworks Ordinance**

The Fourth of July will soon be among us all. I would like to remind the people of Hermon, that Hermon does in fact have a written ordinance banning the usage of consumer fireworks within town limits.

#### **Prohibition:**

The ordinance states no person shall use, possess with the intent to use in the Town of Hermon, sell, possess with the intent to sell in the Town of Hermon, or offer for sale consumer fireworks.

#### Exception:

This section does not apply to a person issued a fireworks display permit by the State of Maine pursuant to 8 M.R.S.A. 227-A.

#### Seizure and Disposal of Fireworks:

The Town may seize consumer fireworks that the Town has probable cause to believe are used, possessed or sold in violation of this section and shall forfeit seized consumer fireworks to the State for disposal.

#### Penalty:

Whoever violates any of the forgoing sections of this ordinance shall be punished by a fine of not less than \$100.00 nor more than \$1000.00 for each offense. In the event of legal action by the Town of Hermon is required to enforce this ordinance and the town is the prevailing party, it must be awarded reasonable attorney fees, expert witness fees and costs.
