Paving on the Billings Road from the four corners by the Town Office to Route 2 has been paved by B & B Paving. A few housekeeping items to complete include painting lines and fix some driveway entrances along Billings Road.

So the next best thing was Howard and I to meet with the sheriff on Monday. They are going to step up patrols a lot more, they're looking into maybe we can put up some different signs on roads where we have problems. So that's the next step that they're going to be doing. They are going to get some more officers in town. They just want educate people to slow down a little bit. So I'm sure you'll see that on the roads very shortly.

Tony Reynolds: I drove up by the high school and checked out the paving job. It looks really good up there. The lines are all marked. That place was a disaster area the last five years. So I'm glad it's all taken care of now.
