Teachers and administrators collaborated on a "Learn to Snowshoe" event where all families were invited to participate. Bobbie was a great police officer.


He was an even better father, husband, son, brother, uncle, cousin, veteran, advocate, friend, and human. His family was his life.

### **Assessing Department**

HOMEOWERS: Do you qualify for a Property Tax Exemption?

Homestead Exemption: Hermon residents already receiving the Homestead Property Tax Exemption in the amount of \$25,000 in your 2021 tax bill do not need to reapply. The exemption will stay with you property year to year and the exemption will be increased to \$25,000 for this tax year.

New Hermon residential property owners or residents who have relocated from a Hermon owned residential property to another in Hermon: You will need to apply for the Homestead exemption. Go to the website listed below to download an application or pick one up at the Town Office to see if you qualify. ### **Mailbox Guidelines**

Winter poses many challenges; your mailbox should not be one of them. While plow drivers try to avoid mailboxes sometimes it cannot be avoided especially when a vehicle is coming the other way. The plow truck cannot always move over to go around your box.

Here are some guidelines to help you from the headache of a broken mailbox:

The height of the wing on our plow trucks are 43", therefore the height of the lowest point should be at 45". The front of your mailbox should be 12"- 18" from the edge of the pavement, this still allows for your mail to be delivered, as well for us to clear the roadway, and the shoulder.

These are the two best types of posts to put your mailbox on.






By meeting these measurements this is the best possible way to alleviate the headache of a broken mailbox, as we do our best to go around your mailboxes it is not always possible to go around, when there is traffic coming from the opposite direction, the truck can not go around your box, the edge of the dust pan (front plow) sits on the center line with the end of the wing going off the pavement.



# **Community Development Projects – 2022/2024**

At the June 2021 election, voters approved a ballot question for an eight lane track project as an addition to the Hermon High School athletic complex. Design components include track and field event stations, concession building improvements and grandstand seating. Included in the planning process are improvements for the soccer/football field area with new drainage and installed sod to cure playing surface issues as a finish. A dedicated irrigation system to supply the area with suitable capacity will afford the field surface the water needed for strong grass growth creating safer playing conditions. The project is on schedule and expected to be completed summer 2022.



With the completion of the projects, Hermon joins a growing list of communities in eastern Maine that are adding opportunities for fitness and wellness that connect their students and residents. Athletic renovation projects, recreational trails, school facility upgrades and performance arts venues have been supported recently in Bangor, Brewer, Orono and Hampden. These investments offer long term benefits for communities interested in improving the quality of life for people of all ages. Hermon's track project will directly benefit a growing group of families interested in track and field while simultaneously offering a fitness opportunity for residents who desire a safe environment for walking and running!

On February 3, 2021, the Town of Hermon applied successfully for a MaineDOT BikePed grant to facilitate a "safe route to schools" improvement at Hermon Middle School and Billings Road. The Hermon Middle School Sidewalk Project connects a major residential subdivision at Schoolhouse Lane with Hermon Middle School and Hermon High School including village commercial businesses, religious and non-profit facilities and a shopping plaza. The primary goal is to solve a safety issue for middle school pedestrians walking to Hermon Middle School for educational purposes or after hours programming. The project improves the



Billings Road in part which is a "State Aid" highway (minor collector) providing access to the residential, educational and service businesses listed above. Near "misses" between pedestrians and vehicles have been experienced at this location due to gaps in the sidewalk across parking lots, roadways without crossings/flashing beacons and no connectivity currently to the existing sidewalk which would be cured by the project.

Scams: Keep These Tips in Mind

Recently, the Penobscot County Sheriffs Office has been investigating a lot of scam/fraud complaints, especially in Hermon. Below are a few tips that we'd like to share from the Maine Attorney General's Office.

As a general rule, all scams have similar traits. Here are some obvious ones that raise red flags in the Consumer Protection Division that you should keep in mind.

**You are contacted out of the blue.** Anyone who calls, emails, sends you a letter, texts or comes to your dooryard out of the blue may not have your best interest at heart. You don't have to respond right away, make a decision or even answer the door.

You have to send money up front in order to receive a prize. You haven't won anything if you have to pay for it.

You need to send money via wire transfer or a reloadable card. This is frequently the preferred way for scammers to ask for money. Remember, this is just like sending someone cash - you'll never see it again.

You are asked for personal or financial information. Never provide your personal information (DOB, SSN, etc.) or bank account information to someone you don't know. Your bank or credit card company will not call and ask to confirm any account or personal details they already have on file. Anyone asking for this information out of the blue is trying to scam you.

**Don't tell anyone.** Scammers want to keep you under their spell. If you tell family and friends, someone may ask dissuade you from interacting with them. If you're asked to keep it a secret, it is a scam.

**ACT NOW!** If an offer is really good, it can wait for you to sleep on it and get back to them tomorrow. Too many times though, scams have to be acted on today only. We advise you to be slow to say yes and quick to say no.

You get a real looking check. If you get a check and are asked to send money back, it's a scam. If you really think you've come upon unexpected good fortune, take your check to the bank and ask them to verify whether it is real.

### Legislative Update

2022 Legislative Session Update With Rep. Jim Thorne House District 103 - Carmel, Etna (part), and Hermon

### Legislature considering Governor's Supplemental Budget

The Legislature met for only the third time in 2022, to hear Governor Mills deliver her State of the State address. Since then, we have met in session a couple of times, even though most of Maine is getting back to normal. Constituent work has not stopped, but

committee work continues to be done remotely.

I hope that we can begin to return to meeting regularly in person. There is a real value in meeting face-to-face because it builds relationships, leads to better cooperation, and less partisanship on issues that we should all agree on. The legislature should operate more like the people we represent, not insulate itself from the world around us.

The Governor has proposed a number of potentially good ideas in her Supplemental Budget. We are carefully reviewing how she proposes to allocate the projected \$822 million increase in revenues. Thankfully, the Maine Constitution requires a balanced budget, so all funds must be accounted for. I will continue to advocate for returning as much tax review to struggling Mainers as possible. It is their money, and it is needed to pay for the unprecedented increases in living costs being borne by all of us.

Government should not grow bigger as family budgets get smaller due to inflation and higher heating, gasoline, electric, food and other items necessary for daily life. Although the Governor has agreed to return \$411 million taken from taxpayers by sending out \$500 checks, I believe there should be a serious discussion about structural tax reform. The revenue imbalance should not be allowed to continue in the future.

I am not optimistic that there will be any tax reform, or a commitment to letting people keep more of their earnings, until we have a Governor and legislature that understand what is happening in communities across Maine. Part of your money will likely be sent to you before November. If that is the case, people need those funds as soon as possible.

# Representative Thorne Announces Local Projects in Maine DOT Work Plan

AUGUSTA – State Representative Jim Thorne (R-Carmel) is pleased to announce that the Maine Department of Transportation (MDOT) Work Plan for Calendar Years 2022, 2023 and 2024 is available. The estimated value of work in the plan totals more than 2,316 individual work items with a total value of \$3.17 billion. This represents a substantial increase from last year due to anticipated federal funding.

The MDOT Work Plan for House District 103 includes \$755,000 for two projects:

Etna: Highway Safety, Spot Improvements, and Large Culvert Improvements located .73 of a mile east of Etna Road.

Hermon: Pedestrian safety improvements in Hermon, including a sidewalk on the west side of the road extending to Schoolhouse Lane.

"MDOT Work Plan projects will benefit our local communities in many ways," said Rep. Thorne. "I am pleased to see MDOT projects scheduled for the next three years in our area. They will make our roads safer and benefit local economy."


