## IX. PUBLIC HEARINGS:

• **TIF District** #24 – C & K Variety

<u>Chair Thomas opened the public hearing at 8:17PM. Public comments were</u> given. The hearing closed at 8:33PM

## **Scott Perkins presented:**

C&K Variety is located at 4 Billings Road, Hermon, Maine at Map 27 Lot 020 on the Hermon Tax Maps. C&K Variety is currently owned by Tylor E. Perry. The new project is classified as a "mini mart" and is currently under construction to replace the existing C&K Variety at this location in the Village Commercial District.

Future design plans indicate the removal of the existing store at project completion with redefined entrance and larger parking lot because of lot orientation. MaineDOT requirements for entrance permitting include wide and varied improvements to the private property and right of way at Billings Road and Route 2 Intersection. The total estimated value of the finished project is \$1,748,900. DECD staff is requesting the Town Council consider adding Map 27, Lot 020 as a Tax Incremental Financing District. It is proposed that the Town Council approve the request and agree to capture 100% for 30 years of the new value created by the improvements to the real estate at Map 27 Lot 020 beginning 4-1-2023. It is estimated from the preliminary assessment numbers that \$1,512,500 will be added as new value. Based on assumptions outlined above, the following amounts of new value will be captured, and new real estate taxes generated:

## **Ernest Wheeler, Billings Rd:**

- Why are we putting a TIF on an existing business? Scott Perkins: To protect value in keeping it out of the municipal valuation, and the benefit from the state education increases the net subsidy and less county tax you pay and redistribution of that money into infrastructure.
- <u>Is the TIF transferable? Scott Perkins: No, except when the owner makes a request, and the council agrees to transfer the TIF.</u>



# • TIF District #25 – Dollar General

# <u>Chair Thomas opened the public hearing at 8:34PM. No public comments</u> were given. The hearing closed at 8:38PM

# **Scott Perkins presented:**

Dollar General is located at 2440 Route 2, Hermon, Maine, 04401 on Map 27, Lot 088 on the Hermon Tax Maps. The owner, Tom Ellis, is expanding the company's footprint after negotiating a national lease agreement with Dollar General Stores. Construction at the site on 6.73 acres in the Village Commercial Zone includes a new 10,530 square foot discount store creating a substantial amount of new captured value. Ellis Commercial is headquartered in Hermon offering site development and build-to-suit commercial lease opportunities throughout the state. They currently provide commercial property leasing, management and development by assisting with site selection, project consultation, site design, engineering, project management, earthwork and construction. Ellis Commercial has designed and developed medical/dental offices, Class A office space for the United States Government, financial institutions, retail stores, hair salons, grocery stores, fast food restaurants, fitness facilities including other wide and varied commercial opportunities.

The total estimated value of the finished project is \$871,700. It is proposed that the Town of Hermon create a tax incremental finance district for Hermon Holdings, LLC at Map 27, Lot 088 on the Hermon Tax Maps. The Town of Hermon and Hermon Holdings, LLC propose that Hermon agrees to capture 100% of the new value created for 30 years and return 40% of the paid real estate taxes related to the captured new value to the owner, Tom Ellis, for a period of 10 years beginning with the tax year 4-1-2023. Based on assumptions as outlined above, the following amounts of new value will be captured, and new real estate taxes generated:

• **TIF District #26** – Showcase Self Storage

# Chair Thomas opened the public hearing at 8:38PM. No public comments were given. The hearing closed at 8:40PM

## **Scott Perkins presented:**

Showcase Self Storage is located at Odlin Road, Hermon, Maine at Map 8 Lot 030 on the Hermon Tax Maps. Showcase Self Storage is currently owned by R3 Development. The new project is classified as a "mini warehouse" and is currently under construction at this location in the Industrial Zone.

Design plans indicate a total of 350 storage units with an office and bathroom facilities for employees. The total estimated value of the finished project is \$1,589,100. DECD staff is requesting the Town Council consider adding Map 8, Lot 030 as a Tax Incremental Financing District. It is proposed that the Town Council approve the request and agree to capture 100% for 30 years of the new value created by the improvements to the real estate at Map 8 Lot 030 beginning 4-1-2023. It is estimated from the preliminary assessment numbers that \$1,512,500 will be added as new value. Based on assumptions outlined above, the following amounts of new value will be captured, and new real estate taxes generated:

FY 24 Budget

Manager Berry outlined the budget process that has begun at the Town and is looking for feedback from the Council for goals and objections. Things that are being looked into are new staff for the Town, cost of living and increase to county fees.



<u>Danielle Haggerty: Important to maintain a low mill rate. Timeline for the audit to be complete?</u>

Manager Berry: Audit could be completed by end of March or April.

John Snyer: How much new value will the Town have this year?

**Manager Berry: Too soon to predict.** 

Richard Cyr: Would like to know the percent of undesignated funds in the school budget and how many years before the State takes money away.

Danielle Haggerty: Danielle, John Snyer, Manager Berry have been a part of the first budget meeting at the school. The meeting went great and feel we will be in a good place for the budget season. ED279 - School is in position to receive 1 million dollars more next year from the State. The school will have \$1.2 million in wages increase next year due to salaries and contracts. Mr. Micah Grant feels the budget will have approximately \$250,000 dollars in wiggle room in the budget for possible decrease.
