Be it ordered that the Town Council shall hold a public hearing on Thursday, June 27, 2024, at 7:00 p.m. at the Hermon Town Council Chambers to consider the following Charter amendments to Articles IV, VI, and VIII of the Hermon Town Charter:

First Amendment:

Articles Summary

Article VI

School Committee. A Department of Education is created with seven School Committee members, five elected at large from Hermon, being responsible for the care and management of the public schools of the town, and two from S.A.D. #23 RSU 87. empowered to vote on Secondary Education matters.



Second Amendment:

Sec. 4.01 – APPOINTMENT; QUALIFICATION

The Town Council shall appoint a Town Manager for <u>any length it desires</u> an indefinite term and fix his/her compensation. The manager shall be appointed on the basis of his/her executive and administrative qualifications. He/she need not be a resident of the Town or State at the time of his/her appointment but may reside outside the Town while in office only with the approval of the Council.

Third Amendment:

Sec. 6.01 – NUMBER, ELECTION, AND TERM

The School Committee shall consist of five (5) members, each of whom shall be nominated and elected by the registered voters of the entire Town to administer and provide oversight for the School Department.

Each member shall be elected for a term of three (3) years and shall serve until his/her successor is elected and qualified. After serving three full consecutive terms as a School Committeeperson, an individual must wait one year before serving on the Committee again.

In addition to the five (5) members above, there shall also be two (2) members of the School Committee to be appointed by the director of RSU 87 R.S.U. #87 for as long as secondary school tuition students from RSU 87 #87 d/b/a/ SAD #23 are contracting with the Town of Hermon empromise comprise no less than 25% of the secondary education student population at Hermon High School. The School Committee shall have all the powers and duties prescribed for school committees by the general laws of the State of Maine, except as otherwise provided by the Charter as follows:

- (a.) A specific agenda item shall be provided at all regular meetings to allow public input.
- (b.) The School Committee shall provide for keeping a verbatim record of its proceedings to be retained and disposed of in accordance with State Law.
- (c.) The contract between the School Department and RSU 87 shall be for a period of three (3) years.



Fourth Amendment:

Sec. 6.08 – BUDGET

The School Committee shall submit <u>and present</u> its proposed annual budget to the Town <u>Manager</u> <u>Council at a time to be determined by the Town Council pursuant to Section 8.03 of this Charter.</u> no less than thirty (30) days prior to the Annual Town Meeting or Special Town Meeting called for adoption of the school budget along with explanation of any pending items.

Fifth Amendment:

Sec. 8.02 - PREPARATION AND SUBMISSION OF THE BUDGET

The Town Manager, at a time to be determined by the Town Council, shall submit to the Council a budget and an explanatory budget message. The budget authority of the Town Council shall include amending or approving the budget proposed by the Town Manager and determining the total appropriations made to various municipal offices, departments or agencies. The school budget will be presented to the Town Council, which shall determine the total amount of school budget to be presented for school budget validation vote, pursuant to 20-A M.R.S.A. Section 2308(2) 2307(2) and the Town Council will forward the School Committee's recommendation to the voters in accordance with State law.

Sixth Amendment:

Remove references to S.A.D. 23 wherever used in the Charter and replace with RSU #87.

Amendments made by the Hermon Town Council:

Shall the municipality approve an amendment to Article VI of the Articles Summary of the Charter of the Town of Hermon, as set forth below?

Articles Summary Article VI

School Committee. A Department of Education is created with seven School Committee members, five elected at large from Hermon, being responsible for the care and management of the public schools of the town, and two from S.A.D. #23 RSU 87 empowered to vote on Hermon High School Secondary Education matters.

SUMMARY: This amendment replaces "S.A.D. #23" with RSU 87 and replaces "Secondary Education" with "Hermon High School".

Councilor Snyer moved to approve First Amendment: Article VI with above changes. Councilor Cyr seconded the motion. The motion was accepted. Motion passes 5-0.

Second Amendment:

Shall the municipality approve an amendment to Section 4.01 of Article IV of the Charter of the Town of Hermon, as set forth below?

ARTICLE IV - TOWN MANAGER

Sec. 4.01 – APPOINTMENT; QUALIFICATION

The Town Council shall appoint a Town Manager for <u>any length it desires</u> an indefinite term and fix his/her compensation. The manager shall be appointed on the basis of his/her executive and administrative qualifications. He/she need not be a resident of the Town or State at the time of his/her appointment but may reside outside the Town while in office only with the approval of the Council.

SUMMARY: This amendment seeks to make this charter provision consistent with State Law which permits a municipality to contract with a Town Manager for a term of any length it desires.

NOTE: New text is underlined; deleted text is struck out.

Councilor Snyer moved to approve Second Amendment: Appointment; Qualification with above changes. Councilor Gray seconded the motion. The motion was accepted. Motion passes 5-0.



Third Amendment:

Shall the municipality approve an amendment to Section 6.01 of Article VI of the Charter of the Town of Hermon, as set forth below?

ARTICLE VI – SCHOOL COMMITTEE

Sec. 6.01 – NUMBER, ELECTION, AND TERM

The School Committee shall consist of five (5) members, each of whom shall be nominated and elected by the registered voters of the entire Town to administer and provide oversight for the School Department.

Each member shall be elected for a term of three (3) years and shall serve until his/her successor is elected and qualified. After serving three full consecutive terms as a School Committeeperson, an individual must wait one year before serving on the Committee again.

In addition to the five (5) members above, there shall also be two (2) members of the School Committee to be appointed by the directors of RSU 87 R.S.U. #87 for as long as high school secondary school tuition students from RSU 87 #87 d/b/a/ SAD #23 are contracting with the Town of Hermon compromise and comprise no less than 25% of the high school secondary education student population at Hermon High School. The School Committee shall have all the powers and duties prescribed for school committees by the general laws of the State of Maine, except as otherwise provided by the Charter as follows:

- (d.) A specific agenda item shall be provided at all regular meetings to allow public input.
- (e.) The School Committee shall provide for keeping a verbatim record of its proceedings to be retained and disposed of in accordance with State Law.
- (f.) The contract between the School Department and RSU 87 shall be for a period of three (3) years.
- (g.) <u>The School Committee members appointed by RSU 87 shall only be authorized to vote on non-financial, Hermon High School matters.</u>

SUMMARY: This amendment:

- 1. Replaces "S.A.D. #23" with "RSU 87";
- 2. Replaces "secondary school" and "secondary education" "high school";
- 3. Corrects the spelling of the word "comprise";
- 4. Specifies that the length of any contract between RSU 87 and the Hermon School Department must be for a three (3) year period; and
- 5. Clarifies that members appointed by RSU 87 to the Hermon School Committee are limited to voting on non-financial, Hermon High School matters only.

TOWN OF HERMON

MORATORIUM ORDINANCE

ON

UTILITY SCALE SOLAR FACILITIES

The Town of Hermon Council hereby enacts a moratorium ordinance entitled the Utility Scale Solar Facilities Moratorium Ordinance as follows:

WHEREAS, area of the Town of Hermon is suddenly faced with the prospect of increased development pressure from Utility Scale Solar Facilities;

WHEREAS, residents of the Town of Hermon have expressed concerns about such proposed or anticipated developments, including concerns regarding the quality of life, adjacent property values, health and safety, decommissioning costs, visual impacts, and environmental impacts;

WHEREAS, without appropriate regulation, the development of such proposals could pose a threat to the quality of life, adjacent property values, and the health and safety of the Town of Hermon's residents;

WHEREAS, the Town of Hermon seeks to balance these risks with the benefits associated with clean energy projects like Utility Scale Solar Facilities through appropriate regulations;

WHEREAS, the Town of Hermon requires at least 180 days to consider, develop, and implement necessary ordinances and regulations to project the health, safety, and welfare of the residents of the Town of Hermon; and

WHEREAS, in the judgment of the Town Council, the foregoing facts demonstrate that a moratorium on the development of Utility Scale Solar Facilities is necessary pursuant to 30-A M.R.S. § 4356(1).

NOW, THEREFORE, the Town of Hermon hereby ordains that the following Utility Scale Solar Facilities Moratorium Ordinance be enacted:

- I. Authority: This Utility Scale Solar Facilities Moratorium Ordinance is enacted pursuant to 30-A M.R.S.A. § 4356; the Town of Hermon's home rule authority pursuant to the Maine Constitution and 30-A M.R.S.A. § 3001; and section 2.13(6) of the Charter of the Town of Hermon.
- II. Definitions: The following definition shall be used in the interpretation and construction of this Moratorium Ordinance:
- a. Utility Scale Solar Facility: is any solar facility, project, or installation which is intended to or in fact does generate solar power and feeds said power into the electric grid supplying the local utility with power. This shall include any ground-mounted or pole-mounted photovoltaic (PV) project that cover more than ½ acre of land. Residential/commercial solar arrays that cover less than ½ acre of land are not included in this definition. Solar arrays installed on roofs of commercial or residential properties in compliance with existing ordinances and codes are not included in this definition.
- III. Purpose: The purpose of this Moratorium Ordinance is to allow municipal officials a reasonable time to evaluate the concerns raised in regards to anticipated or proposed Utility Scale Solar Facilities, to determine the adequacy of existing land use ordinances and regulations, and, if necessary, develop additional ordinances and regulations to provide adequate protection for the property, health, welfare, and safety of the Town of Hermon's residents.
- IV. Moratorium on Utility Scale Solar Facilities: The Town of Hermon hereby declares and imposes a moratorium, prohibiting the development of any and all Utility Scale Solar Facilities within the Town of Hermon. No person or organization shall develop or operate a Utility Scale Solar Facility within the Town of Hermon.
- V. Moratorium on Processing Applications: No official, officer, board, or body of the Town of Hermon, including but not limited to the Code Enforcement Officer, the Planning Board, or the Municipal Officers, shall accept, process, review, deny, approve, authorize, or issue any applications, petitions, plans, permits, licenses, or requests for approval or authorization involving Utility Scale Solar Facilities development, construction, operation, or use located, in whole or in part, within the Town of Hermon.
- VI. Severability: Any provisions of the Town of Hermon's existing ordinances that are inconsistent or conflicting with the provisions of this Moratorium Ordinance are hereby repealed to the extent applicable for the duration of this Moratorium Ordinance. If any section or provision of this Moratorium Ordinance is declared by any court of competent jurisdiction to be invalid, such a declaration shall not invalidate any other section or provision.

VII. Effective Date, Retroactivity & Term:

- a. Pursuant to the Charter of the Town of Hermon, this Moratorium Ordinance shall take effect 30 days after passage by the Town of Hermon Council.
- b. Upon its effective date, notwithstanding the provisions of 1 M.R.S. § 302, this Ordinance shall be retroactive and applicable, to the maximum extent permitted by law and subject to the severability clause above, to all filed, pending, or future applications and petitions for Utility Scale Solar Facilities which have not received all necessary development permits and licenses from the Town of Hermon and all proposed Utility Scale Solar Facilities that were not fully operational and/or did not have all the required State permits as of November 1st, 2022, the date the Moratorium Ordinance was first proposed to the Town of Hermon Council.
- c. Unless, after notice and hearing, the Town of Hermon Council votes to extend it, this Moratorium Ordinance shall remain in full force and effect for 180 days after its enactment, or until a new and revised set of regulations is adopted by the Town of Hermon, whichever shall first occur.
- VIII. Enforcement: The Municipal Officers are hereby authorized to institute any and all actions, either legal or equitable, that they deem necessary or appropriate to enforce the provisions of this Moratorium Ordinance.
- IX. Civil Penalties: Any violation of this Moratorium Ordinance is subject to an enforcement action under 30-A M.R.S.A. § 4452. Any violation of this Moratorium Ordinance constitutes a nuisance. Each day of violation shall constitute a separate offense. All civil penalties shall inure to the benefit of the Town of Hermon.
