Once you have submitted your article, Town staff will be in contact with you to let you know if the article you submitted will be published. We look forward to hearing from you!

## Strengthening Child Care Across the State

The legislative session can be a whirlwind. The long days followed by late nights can make it difficult to fully appreciate everything you've accomplished for your constituents. That's why the break we legislators are afforded over the summer is so important. Not only is it good for catching up on sleep, but it also allows us to reflect on all that we achieved for hardworking Mainers.

One of my proudest accomplishments was the critical support my colleagues and I were able to deliver to child care providers here in Maine. Working families should be able to access quality, affordable child care in their communities without breaking the bank or forgoing a paycheck. That's why we made child care a priority issue this past legislative session.

In an effort to increase the availability of child care in more communities, we made it easier for new facilities to open. We also maintained critical funding for Head Start and other programs that support Maine's child care system. Additionally, we continued providing a monthly wage supplement for child care workers. When these hardworking heroes aren't well compensated, they may have to find work elsewhere, contributing to devastating closures of child care centers in our rural communities. Giving them this extra bit of support helps ensure that doesn't happen.

Our child care providers are truly the backbone of the workforce, and when they thrive, so does our entire state.

# **HERMON SCHOOL DEPARTMENT**

## **Special Education Child Find Notice**

The Hermon School Department is in compliance with federal and state regulations regarding the delivery of services to all children with special needs.

Federal statutes (I.D.E.A.) requires that the School Department identifies, locates and evaluates all children with disabilities, ages 3-20, residing within the school district. Residents who believe that their child is in need of special education services, whether attending public or private school, should contact David Nason, Director of Special Services, 31 Billings Road, Hermon, ME 04401, Tel. (207) 848-4072.

## **Annual Notice of Student Education Records and Information Rights**

The Family Educational Rights and Privacy Act ("FERPA") provides certain rights to parents and eligible students (18 years of age or older) with respect to the student's education records. A copy of the Hermon School Department's policy statement and administrative procedure is available in each school.

### **Inspection of Records**

Parents/ eligible students may inspect and review the student's education records within 45 days of making a request. Such requests must be submitted to the Superintendent or building administrator in writing and must identify the record(s) to be inspected. The superintendent or building administrator will notify the parent/eligible student of the time and place where the record(s) may be inspected.

Parents/eligible students may obtain copies of education records at a cost of ten cents (\$0.10) per page copied.

### **Amendment of Records**

Parents/eligible students may ask the Hermon School Department to amend education records they believe are inaccurate, misleading or in violation of the student's right to privacy. Such requests must be submitted to the Superintendent or building administrator in writing, clearly identify the part of the record they want changed and specify why it is inaccurate or misleading. If the superintendent or building administrator decides not to amend the record as requested, the parent/eligible student will be notified of the decision, their right to request a hearing and information about the hearing procedure.

### **Disclosure of Records**

The Hermon School Department must obtain a parent/eligible student's written consent prior to disclosure of personally identifiable information in education records except in circumstances permitted by law.

### **Directory Information**

The Hermon School Department designates the following student information as directory information that may be made public at its discretion: name, participation and grade level of students in officially recognized activities and sports, height and weight of student athletes, dates of attendance in the Hermon School Department, and honors and awards received, and photographs and videos of student participation in school activities open to the public (except photographs and videos on the Internet). Parents/eligible students who do not want the Hermon School Department to disclose directory information must notify the Superintendent in writing by September 15<sup>th</sup> or within thirty (30) days of enrollment, whichever is later.

### **Military Recruiters / Institutions of Higher Learning**

Military recruiters and institutions of higher education are entitled to receive the names, addresses and telephone numbers of secondary students, and the Hermon School Department must comply with any such request, provided that parents have been notified of their right to request that this information not be released without prior written consent. Parents/eligible students who do not want the Hermon School Department to disclose this information must notify the Superintendent in writing by September 15<sup>th</sup> or within thirty (30) days of enrollment, whichever is later.

### **School Officials with Legitimate Educational Interests**

Education records may be disclosed to school officials with a "legitimate educational interest." A school official has a legitimate educational interest if he/she needs to review an education record in order to fulfill his/her professional responsibility. School officials include persons employed by the Hermon School Department as an administrator, supervisor, instructor or support staff member (including health or medical staff and law enforcement unit personnel); members of the Hermon School Committee; persons or companies with whom the Hermon School Department has contracted to provide specific services (such as attorneys, auditors, medical consultants, evaluators or therapists); and parents, students and volunteers serving on an official committee (such as a disciplinary or grievance committee) or assisting a school official in performing his/her professional responsibilities.

### **Health or Safety Emergencies**

In accordance with federal regulations, the Hermon School Department may disclose education records without prior written consent in a health and safety emergency to any person whose knowledge or the information is necessary to protect the health or safety of the student or other individuals.

### **Other School Units**

As required by Maine law, the Hermon School Department sends student education records to a school unit to which a student applies for transfer, including disciplinary records, attendance records, special education records and health records (except for confidential health records for which consent for dissemination has not been obtained).

### **Other Entities / Individuals**

Education records may be disclosed to other entities and individuals as specifically permitted by law. Parents/eligible students may obtain information about other exceptions to the written consent requirements by request to the Superintendent or building administrator.

### **Complaints Regarding School Department Compliance with FERPA**

Parents/eligible students who believe that the Hermon School Department has not complied with the requirements of FERPA have the right to file a complaint with the U.S. Department of Education. The office that administers FERPA is:

## **Legislators working locally until January**

Dear Friends,

The Maine Legislature is adjourned until January. With the exception of committee and study work, legislators are back home working in our districts, helping constituents, and preparing for the next legislative session.

Legislative committees are authorized to meet up to twice before January to work on bills that were held over, as well as studies and working groups still in progress.

Governor Janet Mills announced that she will delay action on 61 bills passed this past session until the Legislature returns in January 2026. This pause gives her time to thoroughly evaluate each bill and its potential impact on Maine people. Among the high-profile bills awaiting a decision:

- Internet Gaming: Would give the Wabanaki Nations exclusive rights to operate online gaming in Maine.
- Immigration Enforcement: Prohibits local officials from cooperating with federal immigration enforcement agencies.
- Ghost Guns: Requires serial numbers for untraceable firearms.
- Education: Adds Asian American, Native Hawaiian, and Pacific Islander history to school curricula.
- Environmental Safety: Establishes a statewide system to safely dispose of firefighting foam containing harmful "forever chemicals."

The Governor's office has indicated she is taking time to review these bills carefully and fulfill her constitutional duties responsibly. The Legislature also has the option to recall these bills for further consideration or amendments.

In addition to these 61 bills, nearly 400 others have been carried over to the next session—many of which still require votes. When the Legislature reconvenes, only new bills related to budget matters, governor-sponsored legislation, or emergency proposals approved by the Legislative Council will be allowed.

This year alone, more than 500 bills became law. Governor Mills issued five vetoes, and all were sustained by the Legislature.
