9. CEO Items

A. Code Report – April

<u>Code Enforcement Officer Jessefa Murphy discussed the code report.</u>

• For April we issued a total of 21 building permits, which equates 12 accessory permits (1 accessory, 3 additions, 3 decks, 1 garage, 1 shed, and 3 solar), 9 single family homes for a total of \$3,694,000 in new construction. There was an increase in single-family home permits as applicants aimed to complete submissions in

accordance with the existing code prior to the scheduled update.
We issued 12 plumbing permits made up of 5 internal permits and 7 SSWW.

- We finalized inspections on 2 new single-family homes for the month of April. We now have 101 open building permits which equates to 39 Accessory, 53 New Home construction (Single Family, Manufactured, and 2-3 units, and multi-family 4+ units), and 9 commercial permits (includes commercial and commercial accessory) that will most likely be completed within the next 2 to 18 months.
- The 7 years average for new single-family homes built in Hermon has dropped to 32.4 per year.
- The Planning Board approved 1 commercial site plan and one subdivision amendment.
- The Zoning Board of Appeals did not meet due to lack of applications.
- Beginning April 7th, the MUBEC building codes updated from the 2015 I-Codes to the 2021.
