Memorandum for Honorable Council Members

This document is a summary of the agenda, therefore, for reference and general guidance to discussion only.

Agenda Item - Public Hearing:

The noted public hearings documentation is all in order and the staff support for discussion.

1. Dead River Company. This public hearing is for seeking a zone land use change from Commercial to Industrial at parcel 021-037-000, 2014 Hammond Street.

Agenda Item - New Business:

Order 25-26-21

This order is to authorize the acceptance of the zone land use change from Commercial to Industrial at parcel 021-037-000, 2014 Hammond Street, requested by Dead River Company. All relevant material and documentation have been reviewed by the Planning Board and Code Enforcement Officer, to which the Planning Board recommends and supports the change of zone land use. This request for the acceptance of the zoning and land use change is supported by the Administration and is in order for final Council action.

Order 25-26-22

This order is to authorize the current Town of Hermon Foreclosure Policy to be repealed resulting from recent State of Maine Legislation and Statutory enactments. The Town will follow and adhere to the statutory requirements for all future foreclosure transactions. This request for the policy repeal is supported by the Administration and is in order for final Council action.

Order 25-26-23

This order is to authorize the Town Council to recommend the cash donation from the Holiday Train event, hosted by CPKC (Canadian Pacific Kansas City Railroad) to support local food pantries. The Town has two hosted food pantries that assisted local and neighboring communities for those individuals' needing assistance. The local non-profit organizations are Neighbors Supporting Neighbors and Samaritan Inc, hosted by Hermon Baptist Church. I have submitted to CPKC point of contact the

question on how the process works and if the donation would be split between both. As of today, I have not heard back and will provide guidance at the meeting. The document is supported by the Administration and is in order for final Council action.

Agenda Item - Workshops:

Fund Balance Policy – I have asked the Finance Director, Mr. Cushman, to review and modify the policy to reflect current and best practices. The document from 2006 is provided and the new version. Since the new version has been reformatted, there is no line out document to be reviewed. The draft provided is consistent with current operations and audit recommendations. This is for discussion only with final approval at future Council Meeting.

Public Works Update – I have asked Mr. Perkins and Mr. Haggerty to work with me to define the requirements and long-term direction of the Public Works Department. This discussion will help establish a clear vision and path forward for the department.

At present, the Town relies on vendors and local contractors to complete major infrastructure and public works projects. The existing team primarily handles facility maintenance and smaller infrastructure tasks—for example, minor repairs and projects within the cemeteries and recreation areas, routine maintenance at the Town Office, pothole repairs, sight-distance improvements, and serving as liaisons with contractors for project management and town representation.

Supporting documentation is being prepared to illustrate the potential impact and capabilities of a fully staffed, year-round Public Works Department. This information will also provide a comparison to current operations and the projected costs of continued contractor reliance.

The purpose of this discussion is to help shape the department's future vision and to guide future budget and capital improvement planning.

Zone Change to Industrial – Dead River - Tax Map and Lot 021-037-000

Dead River Company, represented by St. Germain, has submitted a request to rezone their property at 2014 Hammond Street (Map/Lot: 021-037-000) from Commercial to Industrial.

Planning Board Review:

The Planning Board reviewed the request during their regular meeting held on October 21, 2025. Following discussion and evaluation of the application materials, the Board voted unanimously (5-0) to recommend that the Town Council approve the proposed zone change.

During their review, the Planning Board expressed that this request presents an opportunity to improve and clean up the site and surrounding area. The Board noted that, should a site plan application be submitted in the future, additional conditions or improvements may be requested to support the Town's goals for orderly and attractive development along Hammond Street.

The Planning Board has provided a favorable recommendation for the proposed zoning change. The Town Council is now tasked with determining whether to approve the amendment based on alignment with the Town's strategic land use goals and community vision.
